



This contract (the "Agreement") is made on this day of _____ between _____ (the "Operator") and _____ ("MC Blenda") for the hiring of MC Blenda as independent contractors to perform (the "Event") for Operator at _____ (the "Venue"), located at the address _____.

It is agreed as follows:

- 1. Place, date, and time of Event.** The parties agree that the time and place of Show will be Venue, located at the address _____, on the _____ day of _____ at _____.
- 2. Payment.** A 50% deposit of Fee is due on the signing of this contract. This is a required condition for the contract to proceed; if a 50% of _____. If deposit Fee is not tendered upon the signing of this contract, no further obligation for either party comes due. The remaining 50% of Fee is due immediately prior to performance, but may be made earlier.
- 3. Cancellation.** If full payment is not made by the time immediately prior to performance, Show may be cancelled by MC Blenda, and Operator may not seek any damages. Cancellation may be made by Operator before two days prior to the time of Event, in which case Operator's 50% deposit of Fee is non-refundable, but Operator will not have to pay the remaining 50% of Fee. If Show is cancelled within 2 days of Show, Operator must pay MC Blenda's full Fee.
- 4. Force Majeure.** In the Event cannot reasonably be put on because of unpredictable occurrences such as an act of nature, government, or illness/disability of MC Blenda, the 50% deposit of Fee is non-refundable, but no other portion of Fee is due, and the parties may negotiate a substitute Event on the same terms as this Agreement save for the time of Event, with no further deposit of Fee due, in which case a new Agreement reflecting this will be signed by the parties. No further damages may be sought for failure to perform because of force majeure.
- 5. MC Blenda Guest Tickets.** Operator will make available 2 complimentary tickets to Event to use at MC Blenda's sole discretion.
- 6. Parking.** Operator will secure sufficient parking for MC Blenda's within a reasonably convenient distance to Venue for a minimum period of 2 hours prior to the show and lasting until 1 hour after the show.

7. **Security, Health, and Safety.** Operator warrants that Venue will be of sufficient size to safely conduct Show, that Venue is of stable construction and sufficiently protected from weather, and that there will be adequate security and/or emergency medical responders available if foreseeably necessary. Operator maintains sufficient personal injury/property insurance for Venue sufficient to cover foreseeable claims.

8. **Severability.** If any portion of Agreement is in conflict with any applicable law, such portion will become inoperative, but all other portions of Agreement will remain in force.

9. **Riders.** Nothing in Agreement shall prevent any rider from being added to Agreement that is favorable to MC Blenda, as judged by MC Blenda. All riders must be in writing and signed by the party against whom enforcement is sought.
